### **Donald Clifford and Norman Scarth Denied Justice**

We have reported court hearings for Mr Scarth and Mr Clifford. On Monday 10 December 2001 Mr Scarth was due an oral hearing in the High Court, London and Mr Clifford a jury trial in the Central London County Court.

On Monday, the prison authorities informed prisoner Scarth that his application for Judicial Review would not be heard because it was out of time. The High Court informed him that it had not received his application form for an appeal against his conviction and sentence (10 years total). At the same time Bradford Council claimed that he owed £900 for rent and that he was being evicted from his council flat. Mr Scarth sent the necessary form for appeal. He claims that his rent was being paid.

When Mr Clifford appeared at the county court Dr Adoko represented him. The jurors were at the court. The judge informed Dr Adoko that there would not be a jury trial and that there had been a mistake. Also court officials had lost Mr Clifford's file. The whole of Monday was spent in Dr Adoko confronting the judge who informed Dr Adoko, more or less, that he was incompetent and unqualified. On Tuesday Mr Clifford was dissatisfied with Dr Adoko and took a leaf out of the judge's book by saying that Dr Adoko was not qualified and couldn't even speak English. Dr Adoko picked up his papers and abandoned Mr Clifford no doubt to the delight of the Treasury Solicitor and the Ministry of Defence Police.

At 8.20 a.m. on Wednesday 12 December 2001 Dr Adoko telephoned the publisher of VOMIT and gave his version of events which was basically that Ministry of Defence Police could assist civil police officers but could not act on their own. There were other valid arguments to put.

Mr Clifford was warned repeatedly that he could not win against the Ministry of Defence without a jury. He visited the Lord Chancellor's office on Thursday. Staff there were aware of Dr Adoko. Mr Clifford's file was "taken up" to the Lord Chancellor.

Judgements handed down by the Central London County Court and the apparent incompetence of the court staff are such that one has to believe that the Lord Chancellor's Department is submitting what have been termed bench memoranda, secret briefings or case summaries to judges and clerks of courts. Such unlawful interference with the conduct of cases must occur in all courts from Magistrates Courts upwards. It has to stop.

Not long ago we were appalled to learn how members of the public did not intervene when ruffians in Luton, Bedfordshire, were kicking women police officers. When we think how the whores of Chiltern District Council have lied and cheated over the past 10 years we can understand why those thugs attacked omen. The callous indifference and indolence exhibited by incompetent and crooked council staff undermines the whole range of public services. Probably the worst aspect of this is the suffering of innocent children.

Let all victims of Freemasonry study how it works and take comfort from knowing that they are not alone and that many people will believe them

\*\*\* On SEPTEMBER 22nd 1999 the Police accused my older children, Andrew and Shelly, of bad behaviour and of causing criminal damage in GW's (the father of two younger children) neighbourhood [Llysfaen.] They were accused of causing serious injury to a prize horse belonging to a wealthy businessman Mr Dewi Jones. Mr Dewi Jones [of D J Construction] also complained to the police that my kids had stolen things [although he wasn't quite sure what] from his stables .... Following the "registration" of my kids they were rarely out of my sight. I knew immediately that this was another frame-up by the police. The police did not question me until the Wednesday. The 'crimes' were allegedly committed on the preceding weekend. They couldn't tell me the day/time of occurrence, or what "feed" my kids had supposedly fed to the horse, which had caused it to become injured, and in need of 15 stitches. They didn't know if any officer had visited Mr Dewi Jones' premises and seen the wounded animal.

I visited Mr Dewi Jones' stables and his premises that [surprise, surprise] back onto GW's land. I interviewed Mr Dewi Jones' wife. She was clearly flustered and appeared to be lying. When my father and I demanded an investigation a police constable came to see us. He was very cagey and unable to answer our questions. He told us that he'd visit the D J family to find out more. Why didn't he check the police record? After a short while the PC returned to tell us that it was definitely not a case of mistaken identity. The officer then told *me* to visit the D J family to find out more details so that he could then trace the incident on the Police Computer and thus give me the information that I wanted. He might have had to alter the police version of events!!!

I then spoke to D J and his wife and 2 of their employees. There were differences in their stories but all agreed emphatically, "This has nothing to do with Gareth, (GW) nothing whatsoever." They were clear that Andrew and Shell had fed their horse "food that it shouldn't have had." This had resulted in the horse getting colic, "bolting into its stable" and gashing its thigh. One employee, Mrs Cooper, told me that she'd reported the offence to PC 1302. The PC had already stated that although a Mrs Cooper had phoned the police, he hadn't spoken to her. The D J group stressed that Andrew and Shell had been "coming and going all day Saturday and all day Sunday and Monday afternoon." If there was a scrap of legitimacy in any of it, my kids would have been caught and questioned by the police AT THE TIME OF THE OFFENCES because there would've been plenty of time for the police to attend the scene and catch the culprits red-handed.

Social Workers fronted up to question me about the matter. They said that GW had again been in their office with more of his "concerns", one of which was the fact that his neighbours were irate because my kids had again been up to no good and had been feeding *pellets* to his neighbours' extremely valuable horse .... After the Social Workers had seen the transcripts of the secret tape recordings that I'd made of the whole horsy story, they agreed that it was a bit fishy. When my father and I requested another investigation, Inspector Philip Hare showed up. I explained that it was important that I get to the bottom of it all because I feared GW was behind it. Inspector Hare told us that if his findings are that D J and Co had collaborated with GW and involved the Police then that is very serious indeed and needs to be dealt with. But in the next breath he informed us that it would take him over 5 hours to get any answers, that he had no intentions of finding out who's been fibbing and why and that he wouldn't be questioning Cooper. Some investigation!

The result of Inspector Hare's 'inspection' was that there was no doubt over identity - it was unmistakably my kids. He informed me that the horse had been fed only *grass* but had still become ill and had *jumped a barbed wire fence* gashing its leg. [More variation in the plot!] It later transpired that his 'enquiries' had not included the questioning of the police officers or the D J household. He admitted that he didn't know if any officer had attended the crime scene and witnessed the sick

horse and he remarked that he wasn't aware that the horse was so valuable. He frequently emphasised that GW had no input at all on the whole saga, that there was nothing dubious going on and that nobody was lying. With regards to the stockpile of referrals made by the nameless GW, Inspector Hare declared that harassment need not be tolerated and that I should ask Social Services for the identities of the persons watching my children and me. But when I informed him that they wouldn't divulge such information, he just shrugged. So much for the protection of women and children!

I wrote to the Police Complaints Authority but my complaint was referred back to the police for them to investigate themselves!!! The 'findings' of Chief Inspector Scott were that my children were "exonerated, they having done nothing wrong" and yet he concluded, "I'm perfectly satisfied that all police officers have acted correctly." Talk about conflicting statements! There was no apology and no explanation, just the brief additional patronising comment, "Finally Miss Kilby, I sincerely hope that you now have a clear understanding of the situation as there is nothing further we can assist you with in regard to this particular matter."

Last week we reported how Jerry Brandel was confused about her experience. She seems to suffer flashbacks. However if she is right in her belief that Masons are involved it is possible that she is constantly under the influence of drugs. In order to show how traumatised she still is here is her own report with minor corrections to grammar.

\*\*\* I was gang raped in Rolla Missouri by fraternity brothers who claimed to be Masons. They said they could get away with it be cause they ran the school. I was raped in the name of God and the name of Satan - Satan being the higher power. They drugged me. They made me dance. They raped me everywhere including they put it in my nose. They video taped the whole thing. They were charged with rape, 3rd degree assault and sodomy. They told how some of the presidents

were also Masons and proud of the fact that they were also. I think I was given the date rape drug cause I didn't remember for a long time what had happened - at least 13 years. It happened in Rolla Missouri. We held a mock suicide a mock burial. At first when I remembered I thought I had to die. I believe they made me believe it was called the rape of the innocent. I was fascinated with dolls and pictures of pretty women and I couldn't find out why. I realise everything has a reason. When the ambulance came they said I was jealous and got upset and went to leave and fell down. The real truth is I couldn't breath because one of them picked up my head and banged it hard on a cement floor. He claimed he had 3 signed affidavits of guys who had been with me but had not only during the rape. At the beginning all the men were asked if they ever slept with me and they had all said no. The man who brought me there had said at the end they always tell. Don't try and protect her cause there will be a punishment for lying. I thought they were all Gods. Don't ask me where I got that from. Before the rape was over they already had a lawyer there and waiting. At first this guy kept coming to me and being very nice. Each time I fell for his niceness. Then he would turn violent and evil. I had to answer questions about everyone I knew everyone I dated and was raped for each of my sins. You can put my name on here cause I would like to know if there were other women out there who had similar experiences. I am not the one who should feel guilty. They did it and are bad. I never met any of these guys before the night but they knew I would not remember. So they told me their names and when I remembered it was my turn they said I killed my baby. I even held her in my arms but I didn't have a baby girl. I passed out and just laid there limp. This was in 1983. I have found the ambulance driver, a sheriff and police officer who remember such a rape but I refused to go to the hospital - not that I knew what I was doing. These people do get Renee Brandel \*\*\* away with rape and other things. Note the name change from Jerry to Renee Brandel. We think that this lady needs help.
