PROTECTION FROM HARASSMENT ACT 1997

This Act has been used unlawfully by the police to stifle criticism especially of Freemasonry. Michael Croley was a victim of Dorset Police and Maurice Kellett was a victim of Northumbria and of Durham City police. VOMIT was to be prosecuted by Chief Constable Pollard of Thames Valley Police on the basis of a complaint by some twat named John Hearn who is presumably associated with the neighbouring cocaine site.

The latest judgement shows that H Hearn & Son and Hellmann Parcel Systems (a subsidiary of Hellmann International Forwarders) occupiers of the adjacent cocaine site, {stolen from the Combined Charities Trust} have harassed us daily for over two years by, inter alia, (a) creating heavy traffic from before 6 a.m. until after 8 p.m. (b) making a malicious complaint to the police (c) permitting vehicles to use the public footpath alongside our premises to travel at dangerous speeds (d) requiring us to put gates to our yard to keep visiting vehicles from using it (e) generally rendering our premises unusable. Both companies have benefited from widespread corruption in Chiltern District Council, the Environment Agency, the Environment Agency Board and Prescott's transport crooks. For more than 12 years Thames Valley Police have harassed us because we were blowing the whistle on corruption.

Genuine harassment is always harmful to individuals who can successfully claim compensation against the guilty party. Under the Act one cannot harass a company but a company or its servants can harass an individual. A recent judgement (Times Law Report of 15 November 2000) by Mr Justice Douglas Brown established the headings under which harassment can occur. In order to do so Douglas Brown had to study the Parliamentary record of the speeches related to the act. **The Act was directed at stalking, anti-social behaviour by neighbours and racial harassment.**

We again draw attention to the heavy-handed and life-threatening raids by policemen between August and November 1999 against Norman Scarth in Leeds, Maurice Kellett in Northumbria, Peter and Pat Prankerd in Cornwall, Peter Hayward in Kent and James Todd in Thames Valley. Blair is the absolute authority. He is allowing police forces and police authorities to get away with murder.

Last week we gave this organization free publicity while making it plain that we do not recommend any donations to charities. Someone giving his name as "Peter Hayward" has taken us to task for suggesting that ELC might not be perfect. Mr. Hayward has extolled the virtues of ELC at length with the obvious intention of persuading us to print his report to atone for something we did not publish. Every charity is a target for unscrupulous people who milk the charities dry. A few days ago the auditors criticized the National Society for the Prevention of Cruelty to Children because more money was spent on "organisation" than on children. If the Charity Commission made sure that such crooks were prosecuted charities would not provide a soft touch for people who are incapable of earning an honest living.

Perhaps Peter will now provide us with details of how the non-charity, Litigants In Person Society, obtains funds. Does it borrow money or rely solely on its percentages from successful litigation?

In Scotland the Accounts Commission (now Audit Scotland) published Annual Reports with a review of where local councils accounts had gone wrong I reviewed these statistics and found that of the 32 local councils, 19 are audited by the Accounts Commission the remainder, normally the smaller and more remote authorities, are audited by independent auditors. Interestingly 38% of the independent auditors found specific issues, notable enough to mention in the Reports, but

Your readers will not be surprised that future Annual Reports left out such information, so no more invalid statistics could be culled, from which any reasonable person could conclude Audit Scotland covering-ups!

Dorset's Dirty Scum [Unedited]

Again interesting. I refer you to my letter dated 24 November 2000, and my reference to the local Government Act 1972, as amended by the Local Government (Access to Information) Act 1985.

The inserted Sections 100A to K would be vital if police authorities are "relevant authorities":

Sub-Section 100C(1)(a), says that minutes shall be open to public inspection.

Sub-Section 100H(4) says that, without reasonable excuse, any person having custody who intentionally obstructs a person exercising a right under I00C(1), shall be liable on summary conviction to a fine, i.e. we are talking criminal, as I understand it. (complaint to police, etc)

Sub-Section IOOG(3)(a), says that the offices of local authorities should have a written summary of the public's rights of attendance and access to documents. (Edinburgh did not have one, when I

enquired, after complaint to the Commissioner for Local Administration, they now have a summary.)

Further the Local Government and Housing Act 1989 at Section 5, requires every relevant authority to have a Monitoring Officer. Are English police authorities required to have Monitoring Officers? The Lothian and Borders Police Board have one!

The receptionist mentioned in VOMIT, was unlikely to be the person who has "custody" of the minutes. May I suggest that Julie Croley correspond with the Dorset Police Authority to establish their understanding of their legal position? I would like to Speak to the Croleys, but you have never given their number out? Antony Jack

Comment: Major Jack is the man who should be Chief Constable of Dorset or Thames Valley or, better still, HM Chief Inspector of Constabulary for England and Wales.
